CALL TO ORDER: The meeting was called to order by Board President, Luke Moorman, at 9:20 am.

CONSENT AGENDA: Amber VanBuren corrected the date of the Las Olas Wine and Food Festival on the Executive Directors report to reflect April 5, 2019 instead of Nov 5, 2019.

The following motion was made by Jodi Tanner and seconded by Stacy Ritter to accept the Consent Agenda as presented to include the Minutes of the Nov 13, 2018 Board Meeting, the Treasurers' Report, and the Executive Director's Report.

COMMITTEE REPORTS: The following Committees presented reports –

MAGAZINE COMMITTEE – Caroline Carrara was absent so there was no official report. Amber gave a summary of content and showed all the magazine on LasOlasBoulevard.com. No issues with this edition other than a box of magazine left on the ground outside of Timpano reported by Alice Harry. Erika Del Rio mentioned she does not get a copy at Gran Forno Pronto and would like to.

CHRISTMAS ON LAS OLAS COMMITTEE – Luke Moorman shared that Christmas on Las Olas was a great success!! Luke spoke about the state ABT Office citing the Association for violating the 123 Permit rules. Moving forward, Christmas on Las Olas and the Association must change how we operate bars under 123 permits. All restaurants are not allowed extension of premises for alcohol service when LOA pulls 123 permit, AND LOA may NOT employ restaurant staff to operate bars. Adam Robin commented that he and all other restaurants were cited as well and they would never again be able to sell alcohol in the street or would risk a fine and jail time. LOA must purchase alcohol and claim all revenue with state (pay FLA sales tax). This was an extended discussion about additional work and liability for the Association and specifically the Executive Director for the coming year. It was agreed there would be more conversation moving forward.

Vann suggested vendor parking at the Las Olas Company garage for Christmas on Las Olas.

MARKETING COMMITTEE – April Kirk announced last month the Marketing Committee was not meeting again until Jan 2019.

MEMBERSHIP COMMITTEE – Bill Renaud read a formal report attached to these minutes. Bill announced he would not be running for the Board in 2019 and that the non-participants they met with felt the board was stagnant and needed to change.

OLD BUSINESS: The following item was presented for discussion –

Amber reported the current board members Erika Del Rio, Caroline Carrara, and Charlie Ladd would be running for their seats as well bringing the total candidates to 9 with 5 seats available.

### **NEW BUSINESS:**

Downtown Coalition – Amber reminded the group of an action item in her ED report to discuss and review the NEW advocacy/lobby group identified as "The Downtown Coalition". LOA Legal Counsel Josh Brandsdorfer advised that LOA is not set up to sign on to any lobby group without formally voting to do so. LOA Board Members April Kirk and Charlie Ladd are attending their meeting this morning which was held at the same time as LOA Board meeting. This item will be placed on Jan 8 LOA Board for further discussion and input from April and Charlie.

Budget Review – LOA will need to take a hard look at 2019 budget and operations costs. New funding sources need to be identified to maintain current level of operations or LOA will need to reduce level of service in 2019.

Executive Director Review – Amber is asked to leave the room while the group discusses retention, possible bonus, raise – and ED pay structure for 2019. Upon return, Amber was presented with end of year bonus and 10% increase in pay with a future conversation about pay structure to include HER input.

<u>CALL TO ORDER</u>: The Las Olas Association Board Meeting was called to order at 9:03 am by President Luke Moorman.

President Luke Moorman began the meeting by acknowledging those Board Members who will not be returning to the LOA Board and thanked them for their service.

<u>CONSENT AGENDA</u>: The following motion was made by Vann Padgett and seconded by Stacy Ritter: <u>Accept the LOA Consent Agenda as presented including the Minutes, Treasurer's Report, and Executive Director's Report.</u> Motion Passed.

### **COMMITTEE REPORTS:**

<u>MAGAZINE COMMITTEE</u>: Caroline Carrara reported that the committee is more organized with an outline of editorial calendar ideas. The February/March deadline in January 18<sup>th</sup>. The overall theme for the upcoming issues is Valentine's Day, food, and wine. Bill Renaud will be the CEO profile written by Jennifer Nayak. There were problems with the printer for the last issue.

**COLO COMMITTEE**: Luke Moorman reported that there was closer scrutiny and oversight by the Division of Alcohol, Tobacco, and Firearms (ATF) over alcohol sales on the Boulevard as part of the event and through businesses on Las Olas. This will create new parameters for the future of the event and impact the future alcohol sponsorship. This will impact the dynamics of the event and how alcohol can be sold during COLO.

MARKETING COMMITTEE: April Kirk reported that she would like to discuss the future of the Marketing Committee after a new Board is elected. It is her recommendation that the Marketing Committee only meet quarterly to review proposals but not take on new financial obligations. The Committee can still oversee Las Olas Locals and the Concierge Event but there should be a focus on Membership and bringing money into the Association instead of pushing money outward. There was a discussion on how to generate revenue to replace the \$20,000 lost in advertising revenue.

<u>MEMBERSHIP COMMITTEE</u>: Bill Renaud reported that the committee hasn't met since their last meeting. There was a discussion about raising the Membership Fees for 2020. Luke will present the topic at the upcoming Membership Meeting next week. The new LOA Board can make the final determination on the cost of 2020 dues.

### **OLD BUSINESS:**

<u>FINAL BALLOT FOR 2019</u>: The final ballot for 2019 was approved and distributed to Membership for review. The Membership Meeting on January 15, 2019 is mandatory but if a Member cannot attend or send a proxy, they can vote by email before 5pm on January 14<sup>th</sup>. Only one person from a Member organization can vote.

**DOWNTOWN COALITION**: Charlie Ladd shared that this is a group created in October or November by the DDA and Riverwalk and brought together represents within downtown including museums, Property Owners of Las Olas (POLO), the Chamber, and others to lobby and market downtown focused topics. The Las Olas Association was invited to participate.

There was a discussion on how much the Association can participate if the purpose of the group is to lobby. The group has already included LOA on communications to the City Commission which they were not given approval for. There was concern by Stan Eichelbaum on excluding residents from the conversation about the downtown.

It was agreed that it is important to be at the table and a part of the conversation. Charlie Ladd and April Kirk expressed that they are both already representing other groups at the Coalition and LOA should pick a representative. There was discussion and concern over how this was being funded and if LOA would be asked to pay dues to participate. Luke Moorman stated that we need to see their By-Laws and organizational structure to better make a decision on how we wish to participate. Josh Brandsdorfer agreed with Luke and shared that we should review the mission, By-Laws, voting procedures, as well as have a clear understanding of how LOA can "opt-out" of items it does not want to advocate for.

**EXECUTIVE DIRECTOR'S CONTRACT**: Amber Van Buren shared that it was discussed that she would meet with Caroline Carrara and Jodi Tanner to review a payment structure and contract. The group hasn't met yet due to the holidays.

### **NEW BUSINESS:**

<u>LIFT STATION ON 8<sup>TH</sup> AVENUE</u>: Charlie Ladd asked Amber Van Buren to send the City a letter regarding the lift station at 8<sup>th</sup> Avenue. It is requested that they move the staging off the street and open it back up to traffic.

ART & DINE: Evan Snow and Andrew Martineau solicited LOA to support Art & Dine as part of the 2019 Art FTL. It was discussed that the request came in very short notice and it is not something that the Association doesn't normally do. They are welcome to solicit restaurants on their own and we can send a communication to our Members to get in touch with them directly. There was a discussion on needing to look at the event closer to see if we wish to get involved and if so, these conversations should begin in the summer.

<u>PRESIDENT'S WELCOME</u>: President Luke Moorman began the meeting by acknowledging the Historic Stranahan House Museum staff for hosting the meeting. Luke asked the attendees to take a moment to remember Kevin Lane, Las Olas Association's Publicist, who passed away last fall.

<u>POLICE AND SAFETY UPDATE</u>: Police Officer Aiden Finnegan shared the December Police report which spanned the area from Andrews to 1700 East Las Olas and Broward Boulevard to the New River. Officer Finnegan stressed the importance of having updated Trespass Affidavit so that that police can remove trespassers.

The removal of the homeless camp at the Main Library has resulted in less homeless individuals congregating on Las Olas. Luke Moorman did remind the group that if they are experiencing issues (especially non-emergency ones), it is important to call police non-emergency to document the cases.

<u>VICE MAYOR BEN SORENSEN</u>: Luke introduced Vice Mayor Ben Sorensen, City of Fort Lauderdale Commissioner representing District IV (which encompasses most of the Association). Vice Mayor Sorensen shared his vision for the City with a focus on downtown Fort Lauderdale. He welcomed everyone to contact him with any questions and concerns anytime.

The Las Olas Working Group will meet on January 24<sup>th</sup> and there will be a discussion regarding scooters on February 5<sup>th</sup>. The Vice Mayor recognized Amber Van Buren for all her hard work on behalf of the Association and all the businesses in downtown Fort Lauderdale.

<u>INTRODUCTION OF BOARD CANDIDATES:</u> Luke Moorman introduced the current Las Olas Association Board Candidates –

The floor was open so the Membership can ask questions of the Candidates.

The ballots were collected by LOA Legal Counsel Josh Brandsdorfer to be counted in the Stranahan House Administrative offices.

### **EXECUTIVE DIRECTOR'S REPORT:**

Amber reported that since her arrival to Las Olas in 2013, LOA has made significant progress in enhancing existing programs and adding new promotional resources, events, and platforms.

In her 5+ years, LOA has sent more than 270 Eblasts, increased email list by 3000, re-designed LasOlasBoulevard.com, quadrupled social media reach, partnered to start LOBI Magazine, reinstituted American Flag décor, re-designed & expanded Map & Guides size and distribution, added annual Concierge Event, created Las Olas Locals Summer Promo, added monthly coffee talk meetings, and added another outstanding signature event.

Amber reported that the number one goal of the Las Olas Association is to drive traffic to Las Olas Boulevard. All the above mentioned does exactly that and is proven by digital data and sales receipts! Amber referred to GFLCVB report and will share the with the group via email.

Amber also noted that Las Olas demographics have seen a significant shift in age groups to 25 years younger generation. The addition of new residential members and the pending construction of coming residential units/members have yielded record setting growth in the downtown which is being accompanied by concerns of construction, traffic, and mobility issues in the downtown corridor.

Amber share there are multiple groups/stakeholders in the downtown seeking to protect their interests and LOA is sitting at all tables representing the businesses. 2019-2020 are planning times for the future of Las Olas and Fort Lauderdale downtown corridor.

**TREASURER'S REPORT**: Caroline Carrara reviewed the 2019 Budget. Last year we broke even and the year prior we had a surplus. In the past 5 years we have maintained a balanced budget.

Changes for the future include -

The Las Olas Association will no longer take care of the light maintenance on the Boulevard. The funding came through a grant which is no longer available. Right now the Association's funds need to focus on other areas so the lights will be removed until funding is available in the future to replace and maintain.

There was a discussion about increasing Membership dues in 2020. More information will be discussed in the future.

There was also a discussion about where else can funds be generated if the expected income cannot be secured. There is currently a 20% buffer in reserve.

The following motion was made by Caroline Carrara and seconded by Bill Renaud: <u>Accept the 2019 LOA Budget</u> as presented. Motion Passed.

LAS OLAS WINE AND FOOD FESTIVAL: Amber Van Buren introduced Chrissy Cohen, the new Executive Director with the American Lung Association who produces the Las Olas Wine and Food Festival. The Lung Association has more than a 20 year history with the Las Olas Association. The event continues to sell out with 50 restaurants, 200 beer, wine, and spirits, and 2,500 guests. All event proceeds go to the mission of creating a world free of lung cancer.

<u>PUBLICITY UPDATE</u>: Andrea Arandia of 1 + 1 Media shared the Social Media reach for the past year including the success of the #MyLasOlasCampaign. There have been almost 1,500 organic posts – no bots or external sources. Most new users are local residents and there has been an increase of 2,000 Facebook likes and 2,000 Instagram likes. Amber Van Buren's promotional efforts have reached half a million people.

Jodi Tanner shared that you can tell the increase in engagement as it transferred to actual people on the Boulevard and at events.

Andrea shared that if any business needs help with flyers or to learn how to use Instagram, to please contact her.

### **LOA Executive Directors Report Feb 12, 2019**

Membership – 59 Total New and Renewed members as of Feb 5<sup>th</sup> yielding \$24,000 in revenue.

LOA Membership Budget Goal for 2019 is \$30K

We have 30 potential members who have either not renewed or are in process of renewing.

Given this is the largest number of memberships confirmed this early, we are well on pace for meetings and exceeding out budget goal for 2019. (Current Membership report attached)

Majority of ED time for Jan/Feb wrapped around membership renewal/cultivation/updates of website to reflect New members and remove nonmembers.

Las Olas Boulevard website – Las Olas Boulevard.com is consistently maintaining the 60% increase in traffic compared to a year ago. Given the shoestring budget and the very large website, Gatman and AVB work together to increase the numbers each month. In January 2019, Las Olas Boulevard.com came up on page 2 in google search for Fort Lauderdale Restaurants when one year ago it didn't show up at all. We have not only increased rankings for Fort Lauderdale Restaurants, but also for Events in Fort Lauderdale, Things to Do in Fort Lauderdale, and Shopping in Fort Lauderdale. Our primary demographic remains domestic travelers and local visitors in the age range of 25-55yr of age with the largest share being 25-34yrs old. The gender share is 60% female – 40% male. (all verified through Gatman Media reporting and google analytics)

# Las Olas Association, Inc. 2018 Financial Analysis

### **Financial Position**

Overall, the Association appears to be financially sound. As of December 31, 2018, you had approximately \$59,000 of cash and receivables that are currently due. The net assets of the Association is approximately \$54,000. Additionally, those liabilities that make up the difference are actually deferred revenue or cash that you received in 2018 that represents income for 2019. That is the result of the street closure income for January that has already been received or included in the accounts receivable.

### Profit and Loss and Cash Flow

On an accrual basis, the Association lost \$15,500 during the short year February 1 through December 31, 2018. However, from a cash flow perspective, the Association had a negative cash flow of \$30,400. The difference between the accrual basis loss and the cash flow is a result of both the short-year and timing differences. There was a significant amount of deferred revenue in 2017 that didn't occur in 2018 due the change in year-end reporting. This means that there is income reported in 2018 without actually receiving the money (because it was received in the prior year). Additionally, all of the liabilities were paid in 2018 and there is no significant accounts payable as of the end of the current year.

### **Taxes**

Since there is a loss this year, there is no tax liability. This year's net membership income of \$4,100, that was exempt from tax this year, will be included in 2019 taxable income. However, the net non-membership loss of \$2,800 can generally be used to offset next year's income as a net operating loss.

### Accounting and Bookkeeping

There is a need to better understand the accounting function so that reports that are meaningful to the Association can be generated at any date. The books have been set up in a manner so that profit and loss statements can be generated for each event as well as membership activity and general administrative expenses. However, the accounts have not been utilized properly to generate effective reports. I would be happy to sit down with those involved in the daily accounting to explain and train them in the importance of these items.




### In Loving Memory of Ron Centamore
